Dear Sir/Madam,

It is a matter of great satisfaction that you have extended your cooperation to the optimum regarding the conduct of State Level Bal Shree Selection 2016 as per schedule.

This is to say that on the basis of details furnished to this office in connection with clarification/variation/mismatch from time to time, a list of qualified participants of all age groups on your centre for National Level Camp is annexed at "A". However, complete result is uploaded on National Bal Bhavan website [www.nationalbalbhavan.nic.in](http://www.nationalbalbhavan.nic.in)

## (Section – A)

Further actions in this respect are as below –

1. Schedule of National Level Camp, Date of arrival 21<sup>st</sup> April 2018 (Saturday) and Date of departure 24<sup>th</sup> April 2018 (Tuesday).
2. You may guide/inform apart from your main centre to all other allied centres under your control not only about the result to respective participant/parent but also to inform the schedule as decided at your level with respect to (Point No. 1) so that the participant selected may reach a day earlier to National Bal Bhavan to attend the National Level Camp. Similar requisite information may also be given to participants of NVS/KVS if any of the selected list (Annexure –A) from your centre.
3. Your attention is required towards participants belonging to Differently abled category wherein type of disability/percentage of disability/ special assistance required by these participants may be informed in the prescribed proforma (Annexure-B) latest by **24<sup>th</sup> February 2018 (Email only)**. Data received after the last date will not be entertained.
  - i. Ensure the benchmarks disability as defined in RPWD Act 2016 -  
"Person with benchmark disability" means a person with not less than forty percent of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority."
  - ii. Also the certificates so issued in favor of the participants should be from competent authority/ as per Government of India norms, failing which his/her candidature will stand cancelled.
4. You are requested to provide the list of those participants who want to appear in their **own regional language** (Only in case they have appeared in regional language at state level selection) in the National Level Camp latest by **24<sup>th</sup> February 2018 (Email only)**. Data received after the last date will not be entertained.

5. If there is any deviation in the spelling of the name of the participant(s) the same may be verified with the Nomination Form and other related documents and if required necessary change in the spelling the correct spelling in CAPITAL LETTER duly authenticated by the Director in a separate sheet duly matched with Nomination Form may be forwarded latest by 24<sup>th</sup> February 2018(Email only). Data received after the last date will not be entertained.
6. It is expected that the original Nomination Forms and related documents like Date of Birth, Certificate issued from the competent authority/as per Government of India norms in case of Differently abled participants, affidavit etc. complete in all respect of the qualified participants may be handed over to the responsible escort with an advice to hand over the same personally at the time of registration at NBB to Bal Shree officials only.

**(Section – B)**

**TA/DA to participants and Escort during the National Level Bal Shree Camp**

1. If the group of participants are consisting of Male and Female participants then two escorts (Male & Female) are allowed to accompany the group of children, otherwise only one escort is allowed from identified State Coordinator centres. In case of other than differently abled participants No parents is allowed to escort participants individually. Only the participants will be allowed to stay at NBB with their respective escorts. Parents/Guardians of other than differently abled participants will have to make their own stay arrangement outside the NBB campus.

Further if the Differently abled child is coming to attend the camp then one extra escort/one parent is permitted.

2. Second class sleeper to and fro Journey (NON AC) will be paid to participant and escort.
3. Bus/auto fare from destination to railway station/point of bus transport will be permitted. However, no Taxi and Semi Deluxe/Deluxe buses are allowed.
4. DA will be admissible @ 125/- per child per day and 175/- Rs. For per escorts per day.
5. Percentage of DA is allowed
  - i. For more than 6 hours but not exceeding 12 hours 70%
  - ii. For more than 12 hours – Full DA i.e. 100%
  - iii. DA hours will be counted from round the clock
6. The participants of North East are allowed to travel by Air India Flight up to Kolkata and back. The remaining part of the journey from Kolkata onwards to Delhi and back will be as per admissible TA applicable to other participants.
7. Each participant must have a valid Saving Bank Account and bring a copy of his/her Bank Passbook attested by Parents/Guardian at the time of actual conduct.
