### TERMS AND CONDITIONS of TENDER FOR HIRING OF BUSES

- 1. Sealed Tenders are invited from registered, reputed and established Bus Operators for supply of Buses to National Bal Bhavan—(i) On monthly basis and (ii) on day to day (for casual duties as and when required) on Lowest-1 rates basis for a period of ONE YEAR for providing transportation facilities to children and staff of National Bal Bhavan, New Delhi who have three years experience of supply of buses in the Departments of Central/State Govt./ Semi- Govt. / PSUs/reputed & renowned Institutions (Attach only Satisfactory Performance Certificate duly signed, stamped and issued by the authorities of concerned departments as a proof thereof). Complete Tender document may also be downloaded from the website of National Bal Bhavan i.e. nationalbalbhavan.nic.in. Sealed tenders duly page numbered accompanied with EMD of Rs.25,000/- should be deposited in the Tender Box available at main gate of National Bal Bhavan during working days, weekly off days and holidays. Tenders submitted after last date and time or without EMD will be rejected summarily.
- 2. **Mode of selection of Sucessful Bidder :**Successful bidder will be selected on the basis of lowest(L-1) rates quoted for monthly basis and on day to day (for casual duties as and when required) basis.
- 3. Period of contract for providing transport facilities in National Bal Bhavan is one year from the date of issue of award letter which will be extended by the Competent Authority based on the good bus services provide by the contractor.
- 4. **EMD**: EMD of Rs.25,000/-(Rupees Twenty Five Thousand Only) through NEFT/RTGS has to be deposited by the contractor in the bank account of National Bal Bhavan and mentioned in the reference details thereof in the respective column of tender form.EMD will be refunded to the unsuccessful bidders.
- 5. **Performance Security** :Successful tenderer should <u>have to deposit Performance Security of Rs. 50,000/(Rs.Fifty thousand only)</u> in the Bank Account of National Bal Bhavan through NEFT/RTGS. Full amount of Performance Security shall be forfeited on non-abiding any of the terms and condition and due to non-providing prompt and perfect timely bus services by the contractor and on cancellation of contract. No interest will be payable on this amount.
- 6. EACH PAGE OF THE TENDER DOCUMENT TO BE SIGNED AND STAMPED BY THE AUTHORIZED SIGNATORY WHILE SUBMITTING THE TENDER DOCUMENT. EACH PAGE OF YOUR TENDER SHOULD HAVE PROPER PAGE NUMBERING OTHERWISE THE TENDER WILL BE REJECTED. NBB will not be held responsible for postal delay.
- 7.In the tender, Contractor should have to quote only **unconditional rates** including all taxes, toll tax and remuneration to be paid to Lady Volunteers because National Bal Bhavan will not be responsible to make any payment of remuneration to any Lady Volunteer who will be hired by the transporter. It is the sole responsibility and duty of transporter to hire the Lady Volunteers for buses to be plied during summer session/vacations for children at its own. Rates quoted shall be inclusive of all consumable including CNG.
- 8. The buses will be required by the National BalBhavan, Kotla Road New Delhi for children to travel from various places in Delhi to National Bal Bhavan and back on various days as per requirement throughout the year for which rates may be quoted. No dead mileage will be given by NBB. The tentative Bus Routes for the month of May and June are already uploaded on the NBB's Website:-nationalbalbhavan.nic.in of National Bhavan. Bus routes can be changed as per actual requirement and admission of children.

### 9. Compolsory requirement for each and every Bus to be provided to National Bal Bhavan:-

- 10. Buses to be provided by the Contractor should be in perfectly sound and working condition fulfilling all conditions as prescribed by RTO/competent Transport Authorities for public transport. Buses should be clean and safe. The buses must be registered vehicles having valid permit to ply in Delhi. The Buses to be provided to NBB should always be in good condition and road worthy. These Buses should be registered with concerned Transport Authorities. Drivers must have his valid driving licence.
- 11. The vehicles registered under Bus Quota only should be provided. Private vehicles shall not be accepted as buses and payment of such vehicles will not be made.
- 12. Conductor or Female Volunteer should have to maintain a list of children travelling each & every day and take daily attendance during to and fro jounerys. (Lists to be provided and verified by NBB officials for each route).
- 13. All Buses to be supplied by the transporter will be fully insured from reputed/recognized Insurance Agency.
- 14.Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bank guarantee/demand draft will be forfeited.No request for transfer of any previous deposit of earnest money or security deposit or payment of any pending bill held by the NBB in respect of any previous work will be entertained.
- 15. A person signing the tender form or any document forming part of the tender on behalf of another person/tenderer should have an authority to bid such other person/tenderer and if, on enquiry it appears that the persons so signing had no authority to do so, the NBB may, without prejudice cancel the contract and hold the signatory/tenderer liable for all costs, consequences and damages available under the civil and criminal remedies laws, as remedies.

- 16. The Director, National BalBhavan, reserves all rights to reject any tender without assigning any reason whatsoever and does not bind itself to accept the lowest one or any specific tender. Tender can be accepted/granted in full or in part. If part tender is accepted, the tenderer is liable to accept the same, failing which, the EMD will be forfeited. The decision of Director, National BalBhavan in this regard shall be final and binding.
- 17. In case of breach of any of terms and conditions mentioned above, the Competent Authority will have the right to cancel the work order without assigning any reason thereof, and nothing will be payable by NBB in that event and the security deposit will be forfeited.

### 18. Penalty:-

- (a) In case of breach of any conditions of the contract and for all type of losses caused including excess cost due to hiring of buses from the market in the event of Contractor failing to provide requisitioned buses or not providing buses in time, The Director, National Bal Bhavan shall make deductions at double the rate of Hiring rate on prorata basis from the bills preferred by the Contractor or that may become due to the contractor under this or any other contract or from the security deposit or may be demanded from him to be paid within seven days to the credit of the National Bal Bhavan.
- (b) One male conductor and one female volunteer is to be required compulsory in each bus in view of safety and security of member children. If, conductor and/or female volunteer is not provided by the contractor in any day, the **penalty** at the rate of **Rs. 500/- each person on each occassion** will be deducted from the bill of contractor.
- (c) The powers of the Director, NBB under this condition shall in no way affect or prejudice the powers in certain events to terminate the contract vested in him as herein provided nor forfeiture of deposit mentioned under clause 14 above.

### 19. Terms of payment:

- (a). Payment shall be made neither in advance nor any loan from any bank or financial institution shall be recommended on the basis of the order of award of work.
- (b). The contractor shall submit the bills at each stage/in the first week of following month in respect of previous month (in case of monthly payments) for sanction of the amount of bill and passing the bill for payment. All payments shall be made by RTGS/NEFT only.
- (c). Director, NBB shall be at liberty to withhold any of the payments in full or in part subject to recovery of penalties mentioned in preceding paras.
- (d). The term "payment" mentioned in this para includes only payment as per approved rates for hiring of buses and as per actual requirement of buses NBB is not liable for making any other payment like maintenance charges, compensation etc. Earnest Money and Security Deposit are governed by the separate clauses of the contract.
- 20. **Breach of Terms and Conditions:**In case of breach of any of terms and conditions mentioned above, the Competent Authority will have the right to cancel the work order without assigning any reason thereof, and nothing will be payable by NBB in that event and the security deposit will be forfeited.
- **21. Subletting of Work:** The firm shall not assign or sublet the work or any part of it to any other person or party as the tender is non-transferable.

- 22. **Arbitration:** If any difference arises concerning this Agreement, its interpretation on the payment to be madethere under, the same shall be settled by mutual consultations and negotiations. If attempts for the conditions do not yield any results with in a period of 30 days, either of the parties may make a request to other party for submission of the dispute for decision by an arbitral tribunal condition a sole arbitrator to be appointed by NBB the provision of arbitration and conciliation Act, 1996 and the rules framed there under and in force shall be applicable to such proceedings.
- **23. SHORT NOTICE ORDER FOR SUPPLY OF BUSES**: Some times buses are required on short notices. The contractor/ agency shall supply the buses at short notice or cancellation thereof due to unavoidable circumstances.
- 24. The Firm creating trouble, refusing to do the work or providing unsatisfactory services after getting the award will be blacklisted from National BalBhavan's future tender process. Tenders of such firm will not be accepted by the National BalBhavan in future.
