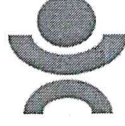

Office Memorandum

Sub: Coverage under Central Civil Services (Pension) Rules, in place of National Pension System, of those Central Government employees who were recruited against the posts/vacancies advertised/notified for recruitment, on or before 22.12.2003-reg.

National Bal Bhavan is receiving various representations from employees who were recruited against the posts/vacancies advertised/notified for recruitment on or before 22.12.2003 regarding coverage under CCS (Pension) Rules, 1972 in place of New Pension Scheme. In this context, it is to inform that the Ministry of Education, Department of School Education & Literacy vide letter No. 1-14/2021-Sch.4 dated 23.03.2023 has intimated to this office that the proposal for coverage under CCS (Pension) Rules, 1972 in place of NPS for those employees of autonomous bodies under Department of SE&L, whose selection for appointment was finalized before 01.01.2004 but joined service on or after 01.01.2004 has been examined by the Ministry of Education in consultation with the Department of Pension & Pensioners Welfare and the Ministry of Finance, Department of Expenditure. The Department of Expenditure vide ID Note No. 25(4)/EV/2020 dated 20.02.2023 has conveyed that since the OM No. 57/04/2019-P&PW(B), dated 17.02.2020 of Department of Pension & Pensioners Welfare was applicable only to the employees of the Central Government, the provision contained in OM dated 17.02.2020 are not applicable to the employees of autonomous bodies under Department of School Education and Literacy.

In view of the above clarification, it is brought to the knowledge of the employees of National Bal Bhavan who were recruited against the posts/vacancies advertised/notified for recruitment on and before 22.12.2003, the provisions contained in the Department of Pension & Pensioners Welfare OM dated 17.02.2020 and 03.03.2023 are not applicable to them. Hence, their request for coverage under old pension scheme cannot be acceded to.
